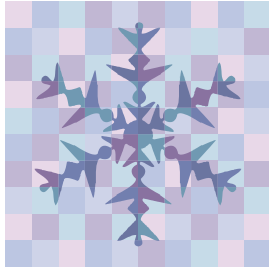


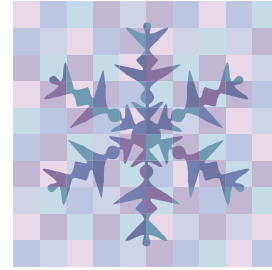

Regular Classes (altered & intact): 6-9, 9-12, 12-18, Novice, American Bred, Bred-By-Exhibitor, Open BM, Open RM, Open Black, Open Red

Note: Crating will be limited in show building. Please, stack crates and use mats under crates & grooming tables. No chalking in building. No dryers within 15 feet from obedience ring. On Sat, March 7th, please avoid parking by DuMor Facility between 7 am to 12 noon.

Show Site: Please clean up after your dogs. All dogs must be leashed or crated and have current vaccinations available upon request. The HWASC, show chairman, their agents, officers of committee shall assume no responsibility for injury or stolen property. Parents are responsible for actions and behavior of their own children. Disruptive behavior will not be tolerated.

Obedience Classes to be offered: Regular Classes: Novice A & B, Open A & B, Utility A & B
Non-Regular: Sub-Novice, Veterans. Wild Card will be offered in an trial only, each day.
All dogs regardless of breed must show in a class appropriate to their ASCA title. No dog may show in a regular and non-regular class on the same day.
These are sanctioned shows, not training matches. There will be NO training in the ring. All dogs must start at the level their dog is competing at in ASCA. A dog with no ASCA title must be entered in Novice.

Attention Obedience Exhibitors. ASCA implemented a new policy as of 1/1/04 stating that every non-ASCA registered dog must acquire a "tracking" number if you wish to earn titles on your dog through ASCA. The cost is a one-time \$10 fee per dog and a one-time \$10 ASCA service membership fee to establish the tracking number.

Directions to Planet Canine:

From east or west, take Interstate 80/90, then get off on exit 96 (County Road 17, Elkhart). Make a left after paying toll. Continue on CR 17. On fourth light, make a right on Beck Dr., veer to the left on Roske Dr., then make a right on Wyland Drive. Planet Canine is on the left hand side.

From the south, take Bypass Hwy 20 east towards Angola. Take the exit for County Rd. 17 and make a left. Make a left on Beck Dr., veer to the left on Roske Dr., then make a right on Wyland Drive. Planet Canine is on the left hand side.
